Introduction

This year, 2019, on holding the pro-tempore presidency of the BRICS (arrangement of emerging countries comprising Brazil, China, Russia, India and South Africa), Brazil coordinated several meetings in order to propose priority themes among these countries.

The Ministry of Health of Brazil in a joint action with the Oswaldo Cruz Foundation, committed to discuss, within the BRICS, one of its most successful experiences of horizontal cooperation: the action Human Milk Bank. Thus, during the 120th anniversary of Fiocruz, the 1st BRICS Workshop on Human Milk Bank was held from August 28 to 30, at the Fiocruz Regional Management in Brasilia (Gereb/Fiocruz), Brazil.

The initiative marked the first time that BRICS, through its health sector representatives, discussed the Human Milk Bank action as a public policy strategy and its benefits for improving the health status of newborns and women in breastfeeding process.

In view of the recognition by the United Nations around the positive impact of the Brazilian experience, the Declaration of the First BRICS Meeting on Human Milk Bank was elaborated at the end of the Workshop, which marked the commitment to mobilize efforts for the creation of the BRICS Network of Human Milk Banks.

During the three days of the event, the participants had the opportunity to get to know the Brazilian model of Human Milk Bank through exploratory visits to the facilities of the Human Milk Banks of the Federal District. The program also included lectures about the trajectory of this action in Brazil; operationalization strategies; alignment with global health; practical classes of processing and quality control, based on the technical-scientific precepts developed by the country; as well as a panel with the experience of each of the BRICS on the subject.

Representatives from Brazil, Russia, India and China

The second activity of the Workshop was the realization of the *Panel – Overview on Human Milk Banks in the BRICS countries* - in which representatives from Russia, India and China presented the state of the art on breastfeeding and human milk banks in their respective countries. The panel provided insight into how each country deals with the Human Milk Bank theme in their respective public health contexts.

RUSSIA

Milana Basargina

National Medical Scientific Center for Child Health of the Ministry of Health of the Russian Federation



In November 2014, the first Human Milk Bank in Russia was opened, located at the Children's Health Scientific Center in Moscow. From this Russian initiative, Milana presented a study that was developed to analyze the public opinion about the need to create human milk banks in the country. At the time, the results of the Moscow HMB were presented, from 2014 to 2019: 280 female donors, over 500L of milk collected from donors, 320 sick children received donated milk. In 2017, the second HMB of the country was created in the city of UFA, located at the Republican Children's Clinical Hospital of the Ministry of Health of the Republic of Bashkortostan, Russia. In 2018, the creation of the 3rd HMB of the country was planned at the Perinatal Center of Chelyabinsk. It was noted that the Russian HMBs constitute the European Human Milk Bank Association (EMBA) structure. Milana highlighted the projection to expand HMBs in maternity and perinatal centers in the country.



INDIA

The Indian representative noted that the first Asian HMB was opened at the Sion Hospital in Mumbai in 1989, and until 2005 it was the only operating HMB in the country. From 2006 to the present day, there was an expansion in this area to 60 HMBs. However, according to Sila, it is still not enough for India, "where the birth cohort is 24.5 million babies." In 2017, the National Guide for HMB (Lactation Management Centers) in Public Health Institutions was launched to contribute to standardization in terms of quality control, communication and regulation of HMB. Sila Deb has shown that 75% of newborn deaths can be prevented by viable and cost-effective solutions, with breastfeeding as the most powerful intervention. Sila also pointed out that in 2015, a group of health professionals came to Brazil to learn about the Brazilian HMB model.



INDIA

Sitaraman presented relevant information from the "Jeevan Dhara" BLH, created in 2015, which operates benefiting babies admitted to Mahila Chikitsalaya and J.K. Lone Hospital. According to Sitaraman, the BLH works hard on the issue of breastfeeding counseling. From March 26, 2015 to August 28, 2019, the following results were achieved: Breastfeeding counseling visits: 33,000 breastfeeding counseling visits; 7400 donors; 3900 liters of milk collected; 5,000 benefited babies; 1050 liters of exclusive human milk provided.





According to Hong Jiang, China's first BLH was deployed in Guangzhou City in 2013, and by November 2018, the country had 27 operating BLHs. For China, the BLH action has brought several benefits, including: survival of premature and low birth weight newborns; decreased neonatal complications, including sepsis and necrotizing enterocolitis; Reduced length of hospitalization: reduced medical costs, increased breastfeeding rates among human milk donors, and treatment for malnutrition, food intolerance, and rehabilitation in children with severe trauma. However, Hong Jiang stated that there are still some difficulties to be overcome, such as moving forward in terms of political sustainability, regulation and standardization of operating procedures.



After the panel, the documentary *International Technical Cooperation on Human Milk Bank: From Local to Global*, was presented, which addresses the trajectory of Human Milk Banks in Brazil and the repercussion of the results achieved for the Country, as well as in the health context. due to the international technical cooperation developed in the sector.

Session III: Exploratory Visit to the Facilities of the Federal District HMB Network

In the afternoon of the 28th, exploratory visits were made to the facilities of the Human Milk Bank Network of the Federal District, guided by Miriam Santos and Graça Cruz (rBLH-DF). The program included the Human Milk Banks of Paranoá Regional Hospital, Sobradinho Regional Hospital and Brasilia Maternal Child Hospital. At the opportunity, the participants could meet Human Milk Banks with different spaces, number of customers, but with the same logic of operation. The visits included discussions with the purpose of expanding opportunities for appropriation of the knowledge and practices presented.







Session IV: Demonstrative Practices of P&QCHM, Following the Brazilian Network Model

During the morning of the second day of activities, the group participated in the routine processing and quality control of human milk, according to the *modus operandi* practiced by the Human Milk Banks in Brazil. Participants were welcomed by the entire Taguatinga HMB team and then met the Project *Firefighter - Breast Friend*, a joint initiative of rBLH-DF with the Military Fire Department for home collection.

Practical activity - processing and quality control of human milk

Miriam Santos explained the process of receiving raw milk. Then all participated in the simulation of processing and quality control of human milk, observing the provisions of the Technical Standards of the Global Network of Human Milk Banks. All participants dressed appropriately and within the processing room saw all the flow - chemical physical quality control, refilling, pasteurization and microbiological quality control. On the occasion, the principles that guide the technical procedures in Brazil and the possibility of their application in the respective contexts of each country were discussed.

Session V: Visit to HMB of a Hospital of the Unified Health System - Supplementary Health Network)

In the afternoon of the same day, the participants visited the HMB of Anchieta Hospital, which is part of the Supplementary Health Network of the Unified Health System. The participants saw, in practice, the Brazilian Law of 1993, renewed in 2014, which requires the Hospitals that have neonatal ICU to have or Human Milk Bank or Collection Station in their facilities.

Declaration of the First BRICS Meeting on Human Milk Bank

We, professionals of the health sector institutions of the BRICS countries, participants of the 1st BRICS Workshop on Human Milk Bank, gathered from August 28 to 30, 2019, in the city of Brasilia, Brazil:

Considering,

The excellence of human milk for the integral development of the infant and young child, as the first and exclusive food in the first six months of the baby's life, and the importance of its use until two years of age or older, as a vital food for sustainable human development;

Access to human milk and adequate nutrition as the first measure of food security for the individual and that every effort should be made to recognize, promote, protect and support this practice, ensuring the reduction of hunger and malnutrition for the child population;

The acknowledgment of the Human Milk Banks Network by World Health Organization and United Nations Development Programme as one of the initiatives that has contributed the most for human development in the Southern hemisphere, promoting practical solutions that have been reproduced, expanded, and adapted by countries, respecting the precepts that rule horizontal cooperation;

The strategic role of Human Milk Banks in Early Infancy public policies from the standpoint of promotion, protection and support to breastfeeding, within the framework of the interculturality of each country; and

The results achieved by the health systems of the countries that are part of the Human Milk Bank Network;

We commit to,

Mobilize efforts, within the framework of the international technical cooperation of our countries, for the creation of the BRICS Network of Human Milk Banks in order to expand sharing of knowledge and technologies focused on food and nutritional security in neonatal and nursing infant care, with the right to health as its central value.
